



## ENCI - a social construction




### **Energy citizenship (ENCI):**

- Citizens leading/following 'the next steps in the energy transition'?
- How to empower energy citizens?
- Where to find the energy citizens?
- How could I become an energy citizen?
- How could I teach my neighbours to become energy citizens?

## What is energy citizenship?

Challenging assumptions of 'deficient' citizens and *passive* energy consumers (Devine-Wright 2007)





### ENCI - as social construction



#### Critical-social theoretical perspective on ENCI:

- ENCI as social construction (indicating political ideals of sustainable, democratic energy systems)
- Co-produced 'imaginary' of involved citizens
- Knowing-of-governance (Voß & Freeman 2016)
- Ideology of empowerment (Swyngedouw 2005; Lennon et al. 2020)

"Energy citizenship refers to forms of civic involvement that pertain to the development of a more sustainable and democratic energy system. Beyond its manifest forms, ENCI also comprises various latent forms: it is an ideal that can be lived up to and realised to varying degrees, according to different framework conditions and states of empowerment." (Pel et al. 2021:64)





# Beyond Manifest ENCI




#### ENCI, political ideal of active citizens


#### From idealism to balanced social-scientific insight:

#### Looking beyond the *manifest* sides of ENCI

- Celebrated, idealized examples as manifest sub-set of social innovation 'niches' (Pel & Kemp 2020)
- Active, innovative, successful ENCI as 'tip of iceberg'
- Manifest/latent political participation (Ekman & Amnå 2012)
- Opening up imaginaries of the public (Chilvers & Longhurst 2016; Rodhouse et al. 2021)
- Next phase of the energy transition: Everybody's business, beyond early adopters and 'frontrunners'
